This contest is concurrently and simultaneously being conducted on several participating radio stations owned by Curtis Media Group, and Curtis Media Group may add or remove participating stations or change call letters of any participating station at any time during a contest as announced on the affected station. Participating stations are: WQDR/WPLW/WKIX/WBBB/WYMY.

The Contest is administered by WQDR/WPLW/WKIX/WBBB/WYMY/Curtis Media Group and any questions, comments or complaints regarding the Contest must be directed to the contest administrator. Every entrant acknowledges and understands that any information provided will be used for administering the Contest and in accordance with WQDR/WPLW/WKIX/WBBB/WYMY/Curtis Media Group privacy practices.

Dates of Contest / The Contest Period: The contest for qualifying for the Grand Prize Event will begin on September 22, 2017 at 5:30a EST and end October 7, 2017 at 4pm EST.

A total of five (5) names will be randomly selected from all entries received at each remote to become qualified to participate in the Grand Prize Event. Listen to the Stations and check the websites for times and locations of remotes. A total of 50 finalists will be randomly selected to become qualified to participate in the Grand Prize Event. All 150 qualifiers will receive tickets when they qualify to attend the Grand Prize Event at the NC State Fair on October 14, 2017 at 4PM EST. The Company is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems. All qualified contestants must check in and register for the event between 2:30pm – 3:29pm EST to be eligible to participate. If the qualified contestant fails to check in by 3:29pm EST, that person will be disqualified from the Grand Prize Event. Only qualified contestants may participate in the Grand Prize Event. Must be present to win, no stand-ins or substitutions will be permitted. Time of the final giveaway event is subject to change. Each qualifier present must check in with the Station representatives to be eligible to participate in the Grand Prize Event and must present a

As each number is randomly selected, the qualifier with the corresponding number will be eliminated from the Contest.
